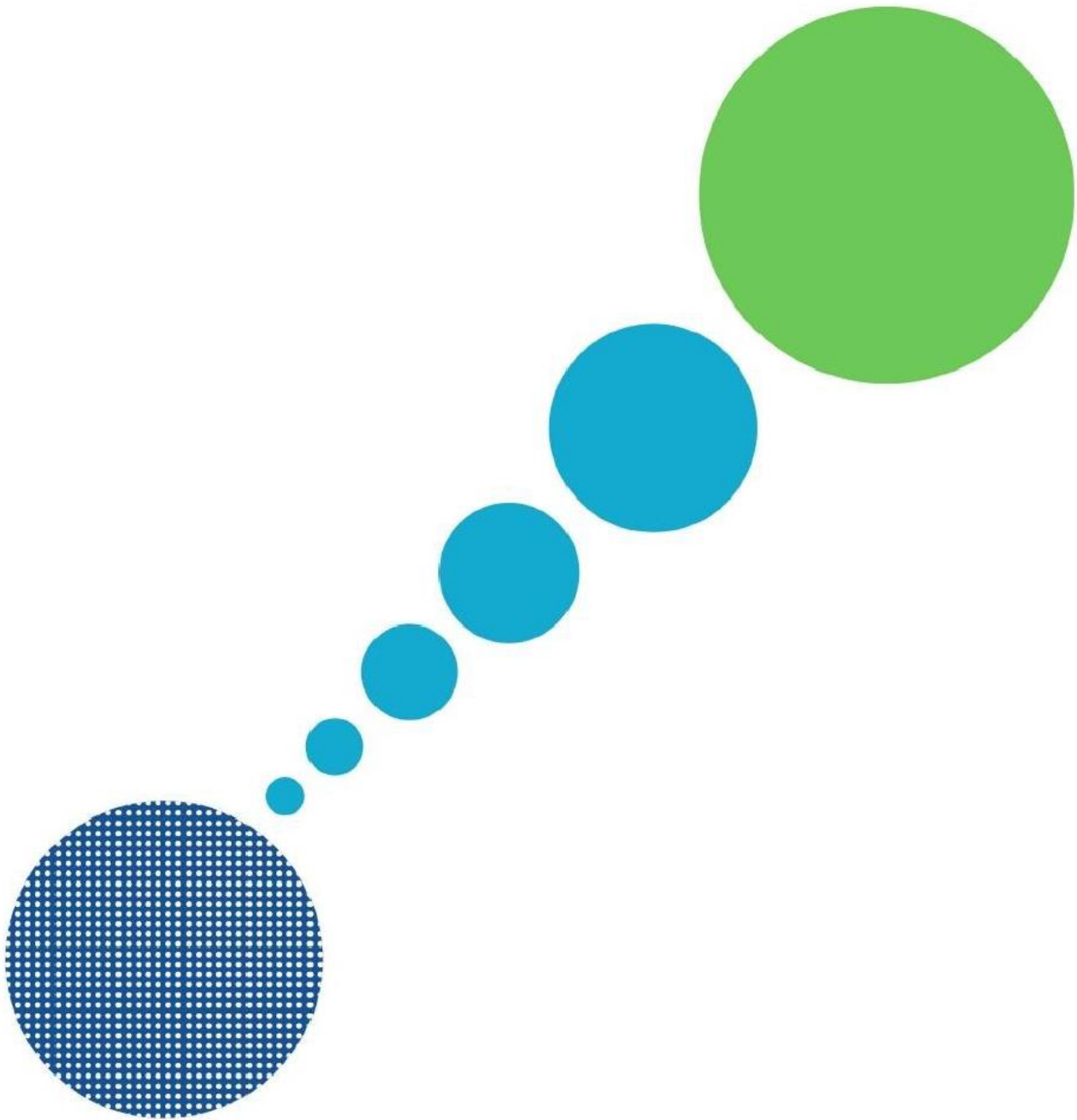

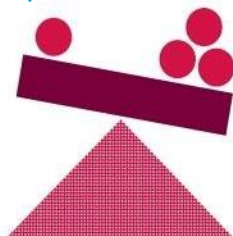

UGANDA

Over the past two decades, Uganda has seen a remarkable turnaround in economic performance. Equally impressive has been the sharp decline in poverty rates, which fell at about 15 percentage points over this period.

Improved macroeconomic management and economic reforms contributed to the country's strong growth performance.

Growth has been driven by the services sector, which has accounted for almost half of GDP since the early 2000s.

Uganda achieved impressive economic growth over the past two decades, with positive per capita GDP growth and stronger growth.

Since the early 1990s, economic growth has been driven by comprehensive macroeconomic and structural reforms. Investment growth also remained strong, with private investment rising and public investment rising by 15 percent.

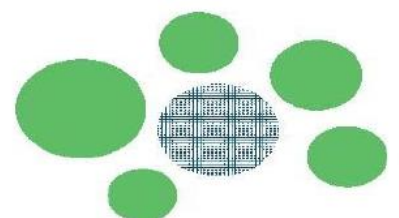
Economic growth has been export led, with the share of exports in GDP rising over the past two decades. The expanding regional market for Uganda's food and manufactured products has boosted exports during the past five years, a reflection of the dividend enjoyed by Uganda's neighbors, whose demand for Ugandan goods has increased.

Uganda continues to register positive economic growth, driven largely by an increase in private sector activity in agriculture, industry and services. Growth has also been a result of an increase in public infrastructure investment especially in energy and roads.

Social services have also expanded significantly, particularly in education and health, in pursuit of Government's policy of universal access.

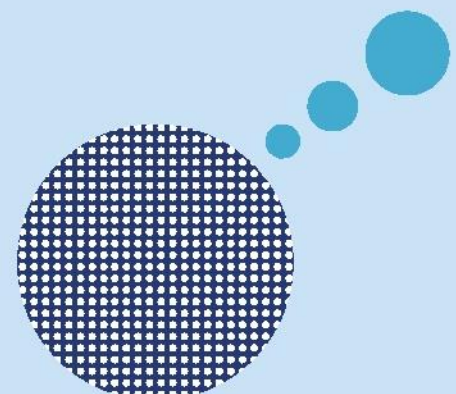

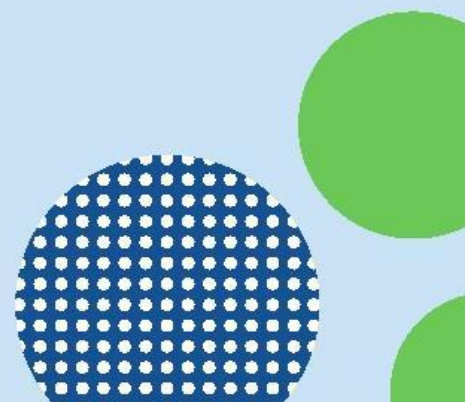
